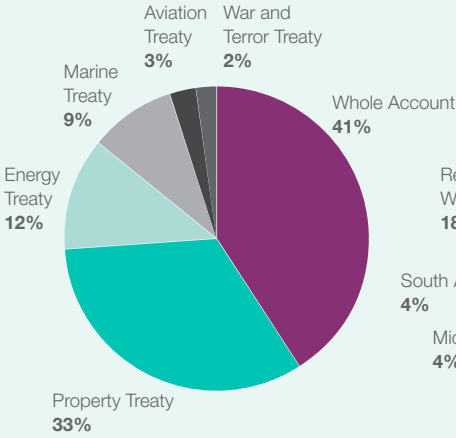

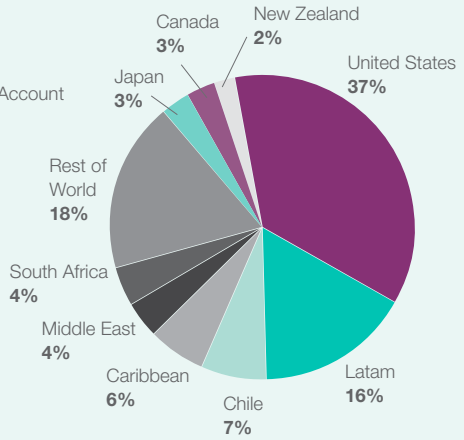
TREATY REINSURANCE

(Premium % Split by Class)



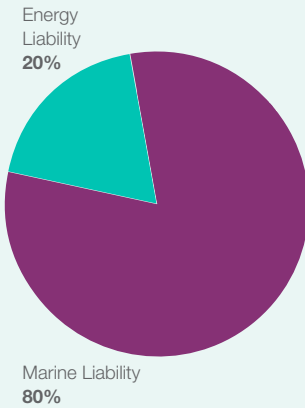
DIRECT & FACULTATIVE PROPERTY

(Premium % Split by Territory)



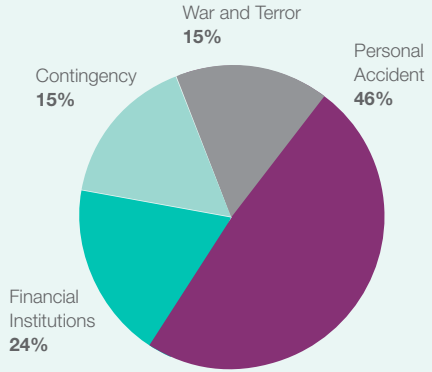
MARINE & ENERGY LIABILITY

(Premium % Split by Class)



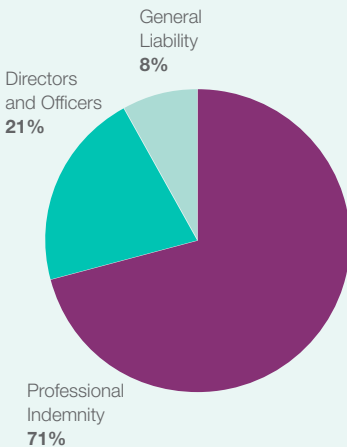
SPECIALTY

(Premium % Split by Class)



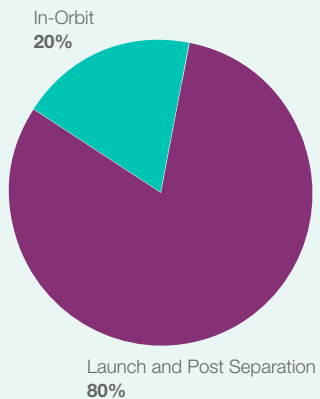
