We boast an increasingly diversified book of business, with 75 premier clients in Casualty and Specialty lines, and more than 200 in Property.

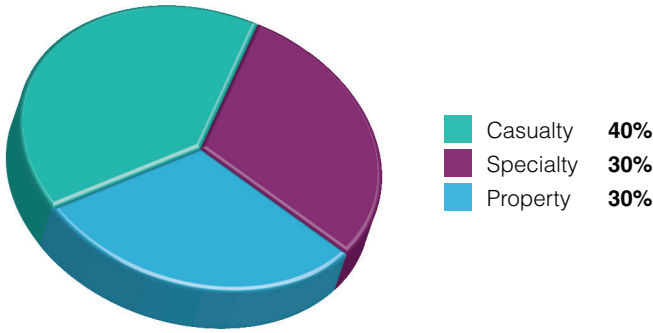

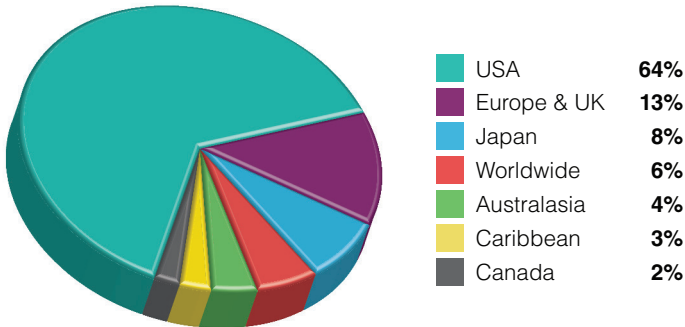
A new vision of risk

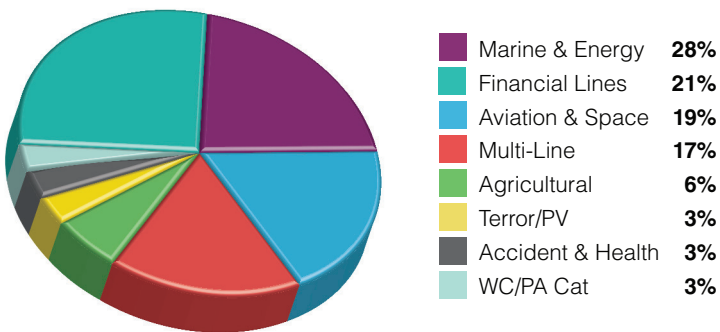
Premium | Split by Line of Business



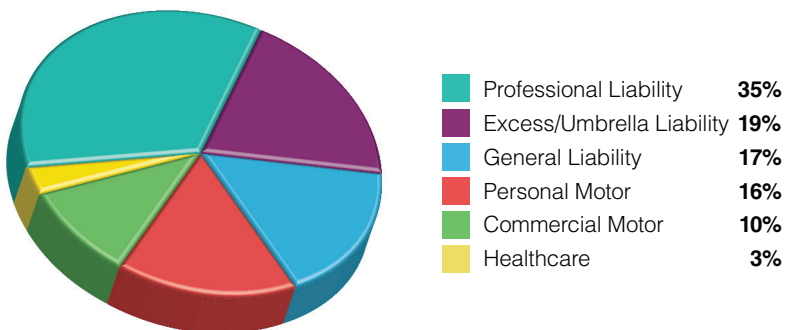
Property Premium | Split by Region
