STUDY FIELD AND LEVEL REQUIREMENTS

DOCUMENT REQUIREMENTS

1. **CV/RESUME:** Summary of institutions attended, work experience, extra curricular activities, volunteer/community work and any prior academic awards
2. **ESSAY:** In up to 400 words, tell us **where you see opportunities for change in the re/insurance industry and why you're excited about the opportunity to support that change.**
3. **GRADES:** Official copies of most recent educational transcripts
4. **STATUS:** Department of Immigration letter confirming Bermudian or Permanent Resident Certificate (PRC) status
5. **LETTER OF ACCEPTANCE/PROOF OF ENROLMENT**
6. **COSTS:** Communication from the university stating their tuition fees
7. **ACADEMIC REFERENCE LETTER:** The letter must be from a current instructor, not a family member, who knows you and your academic abilities.
8. **PERSONAL REFERENCE LETTER:** The letter must be from someone who knows you on a personal basis. This should not be a family member.
9. **PROOF OF FINANCIAL NEED:** While this award is not restricted to applicants with financial need, the Community Giving Committee would like to be aware of any considerations in this regard.

CONDITIONS OF ACCEPTANCE

- Scholarship recipient will keep the Community Giving Committee informed of his/her progress by timely submission of grades or transcripts at the end of each semester and other written reports as may be requested from time to time.
- The Community Giving Committee must be notified ahead of time of any changes to the academic programme undertaken, or of any other occurrences/activities which materially alter the information provided in the scholarship application.
- Failure to comply may lead to reduction, suspension, or forfeiture of the scholarship.

- Our application process opens on February 15, 2018 and closes on April 30, 2018.
