Manages risk exposures through a combination of third-party models and **HARP** (Hamilton Analytics and Risk Platform), **a proprietary risk management platform**

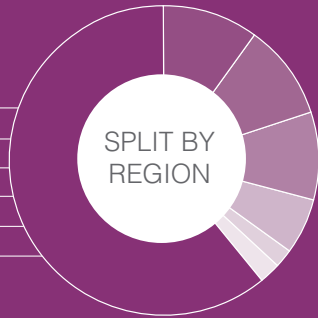

Premium | SPLIT BY LINE OF BUSINESS

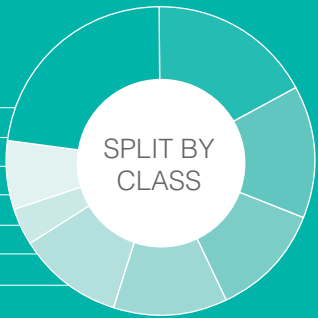

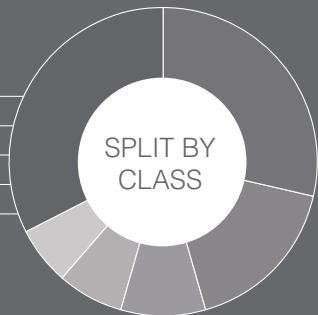
